

He was very sorry that the G.P.C. dinner dance had to be cancelled but from the experience of the J.D.A. Functions Committee it is very difficult to dispose of tickets. For the last three years the J.D.A. has had only a dinner, and was very sorry not to see any representatives of the members present. He hoped that in future some members will go, and also hlped that the J.D.A. would arrange a dinner dance again. He would be pleased to reply to any questions members wished to put to him.

Mrs. Hart said that Mr. Fineberg had said we were self-governing so why did the Council sometimes ask us to cancel functions?. Mr. Fineberg said that for the reasons given in our Chairman's Report, it was thought better not to go ahead with it, but that there was no reason why we could not have a smaller and less expensive function.

Mr. Stellman asked why Mr. Fineberg had not replied to the letters sent to him by the Hon. Secretary. Mr. Fineberg replied that he had no recollection of receiving these letters.

Jack Hart thanked Mr. Fineberg for coming.

6. Hon. Secretary: Mrs. Myers said she did not feel this had been a very successful year for the Club. We were working under very difficult conditions, but just the same we must thank the J.B.S. for their wonderful hospitality.

The review of the programmes is given in the News Letter every month, but she did wish to mention the Grand Bingo, Chanucah Party and Valentine's Dance, for which functions so many people had worked very hard and were most successful. Mrs. Myers felt that Whist Drives ought to be stopped through lack of support, but maybe members would like a Grand Whist Drive every two or three months. Tickets for this would be more expensive than those for ordinary whist drives so that the prizes would be attractive.

Mrs. Myers was very pleased that Mr. Fineberg had come to the meeting and hoped that this would be the start of a fuller co-operation between all Committees of the J.D.A. It was quite wrong that the members own Committee was not allowed fuller participation in the J.D.A. affairs



and the constant limitations in our activities were disheartening. Whilst it is true that without the hearing Committee the J.D.A. would flop, it would also flop without its members.

It had not been easy to work with the Youth Section, and despite many requests for more co-operation, this had not happened.

Mrs. Myers thanked the Chairman for a happy year working with him, he had tried at all times to be absolutely fair and impartial and this was no easy task. She also thanked the other members of the G.P.C. for their hard work.

David Hirshman proposed the vote of thanks and Jonathon Sterne seconded.

Matters Arising: Mrs. Stryker agreed about the whist drives as people do not come. Since the Chairman of the Youth Section was not present it was not possible to discuss their matters. However, in reply to a question about the Youth Section's proposal to charge members of the group 5/- a year membership (in addition to the 15/- paid to the J.D.A.), Ivan Clement said he agreed that this proposal was not right. The Y.S. decided to ask for this before they heard that when the Y.S. closed down 10 years ago, £90 was handed to the G.P.C. for safe keeping. They were told that it is not possible to pay this money back, but that the G.P.C. would be very pleased to help them with any reasonable request. However, they must send representatives to the G.P.C. meeting.

7. HON. TREASURER'S REPORT:

Mr. Myers said we made a good profit last year and he was quite happy about our financial affairs. Mr. & Mrs. R. Denton, Miss R. Kay, Mr. F. Schiller and Mr. D. Jackson have joined the club. Mr. & Mrs. Litenstone rejoined, and Miss C. Koblenz and Mrs. Feld resigned.

We have no Bank Charges, and have approximately 170 members. The accounts are not yet audited. We have £260. 8. 0. in the Bank. The loss of £10.10.8. for Badminton is for 6 months (the first and last 3 months of 1965).

Mr. Myers thanked the members of the G.P.C. for their co-operation and happed they would be satisfied with the accounts.

Maurice Lawrence proposed the vote of thanks and Stanley Senchal seconded.

8. BADMINTON:

Mr. Hirshman said that the Badminton Committee consisted of Lilian Nabarro, and Stanley Senchal and himself. The players were roughly half deaf members and half Compton Committee. They were very grateful to the Council for subsidising the activity. A few friendly matches were arranged, but he was sorry that they were fixed at such short notice that he could not inform the members. He was very sorry that there were no under 25s. playing.

9. NEW RULE:

The G.P.C. proposed that new members must spend one year as ordinary members before offering themselves for election to the Committee.

The proposal was carried unanimously.

<u>Definition of a Country member:</u> Mrs. Myers suggested that people outside the Greater London Council area be charged fees for membership as country members. Mr. Hirshman seconded and the proposal was carried.

10. FLECTIONS:

Mr. Hart reminded members that it was hard work on the Committee and they must be prepared to work if they stand for the Committee. He himself did not wish to stand again as Chairman as he did not find it easy working with the Council.

No member was prepared to stand for the Chair, and various proposals were put forward by which there would be a Caretaker Committee.

Mr. Margulies said that since the G.P.C. are represented on the Council they were in effect complaining about themselves and asked the Committee to continue for 6 months.

No solution could be found and so the meeting was closed.

- 1. The chairman opened the meeting and welcomed all members present.
- 2. Minutes of the last annual general meeting were adopted and signed.

3. Matters arising:

Mr Katz said he would like to see an electric bingo board at our club. Mr Schlisselman said that as far as he knew we had not had any complaints about the old manual method. Mr Myers said that he had wanted to see our club with an electric bingo board too, but that the GPC felt that it was a very expensive item. The few people still at the meeting voted in favour of an electric bingo board, and Mr Hart (J) pointed out that although the proposal was carried it should not be put into effect until next year in accordance with agm practice.

Bingo Leader:

Mr Gold and Mr Katz will lead bingo for the year, but Mr Lawrence will lead on May 4th (grand bingo).

Quarterly Review:

It was agreed that it should be closed permanently as we do not need it with the newsletter.

Elections:

Mrs Sandler asked why we do not take the person who has the second largest number of votes in the elections to be vice chairman, assistant secretary etc. It was pointed out that this is indeed most logical but that frequently a member will stand as chairman but not vice chairman, also some will be vice chairman but not chairman and we must give these people a chance.

Mr Broer asked about the co-opted members of the GPC in the last year. He was told that it is impossible for the GPC to work well with only 9 members, therefore the GPC asked Mr M Solomon and Mr Lawrence (as bingo leader) who are always most helpful if they would join them.

The meeting closed with a vote of thanks to the chair .
